- 1. ON SEPTEMBER 2, 2008, IN RESPONSE TO A REQUEST BY THE BUILDERS DEPOT INC. (BUILDERS DEPOT), THE DEPARTMENT OF COMMERCE ISSUED A FINAL SCOPE RULING THAT THE BUILDERS DEPOT'S AAO TEE BAG (MODEL AAO1) AND AAO2 JACKET BAG (MODEL AAO2) ARE WITHIN THE SCOPE OF THE ANTIDUMPING DUTY ORDER COVERING POLYETHYLENE RETAIL CARRIER BAGS FROM THE PEOPLE'S REPUBLIC OF CHINA (A-570-886).
- 2. BUILDERS DEPOT IMPORTS THE AAO TEE BAG AND AAO JACKET BAG FOR THE STORE "AGAINST ALL ODDS". BECAUSE THE AGAINST ALL ODDS AAO TEE BAG (MODEL AAO1) HAS DIE-CUT HANDLES AND AAO JACKET BAG (MODEL AAO2) HAS HEAT-WELDED HANDLES TO THE SIDES OF THE BAG AND BECAUSE BOTH THE TEE BAG AND THE JACKET BAG HAVE THE AGAINST ALL ODDS STORE NAME AND LOGO PRINTED ON THEIR SIDES, THE COMMERCE DEPARTMENT FOUND THIS PRODUCT TO BE WITHIN THE SCOPE OF THE ORDER.
- CONTINUE TO SUSPEND LIQUIDATION OF ENTRIES OF POLYETHYLENE RETAIL CARRIER BAGS FROM THE PEOPLE'S REPUBLIC OF CHINA, INCLUDING BUILDERS DEPOT AAO TEE BAG AND AAO JACKET BAG LISTED ABOVE, SUBJECT TO THE ANTIDUMPING DUTY ORDER COVERING POLYETHYLENE RETAIL CARRIER BAGS FROM THE PEOPLE'S REPUBLIC OF CHINA.
