11		the full Manufacturing Council meeting. We only have one major item of
12		business, which is to discuss and, hopefully, pass the letter of recommendation
13		from the Workforce subcommittee.
14		
15		So I would really like to thank the subcommittee for all of their hard work and
16		due diligence. This has been extremely difficult letter to get all of the nuances
17		involved.
18		
19		And I really want to thank them for bearing with it. So before I ask Ray
20		Yeager to speak, on behalf of the Workforce Development, has Vice Chair
21		Martinez joined the call? No, okay. Thank you.
22		
23		Ray, I would like to pass the meeting to you, on behalf of Andra Rush and
24		Shirish Pareek of the Workforce subcommittee. Can you provide the context
25		for the letter, Ray, and review the feedback that you received. And, if you
26		could, comment, specifically, on how that feedback was or was not addressed
27		in the letter. Thank you.
28		
29	Ray Yeager:	Yes, I am - I'm prepared to do that. So if we can get started, I do want to
30		sincerely thank Secretary Pritzker, Committee Chair Susan Smyth, Co-Chair

Claudine Martinez, the Workforce subcommittee co-chairs, Andra Rush and 1 2 Shirish Pareek, and the entire Workforce subcommittee members for this 3 opportunity. 4 5 Andra and Shirish send their sincere apologies for not being able to attend our 6 session, today, due to other critical commitments. So I'll go through the 7 context. I will talk about some of the key points, review the feedback and 8 share how the feedback was used in changing our draft to, hopefully, the final 9 edition. 10 11 Most of the manufacturers on this call - and, frankly, most of the 12 manufacturers we speak with around the country - face the same issue when it 13 comes to the future of our industry. We all struggle with finding good, young 14 candidates to fill our Workforce pipeline. 15 16 Some have characterized the situation as a, "deepening crisis." I think over 17 80% of manufacturers in the United States report they find it difficult to 18 attract qualified workers they need to run their production facilities. 19 20 And absent major changes and improvements in the educational system, as 21 well as the public perception of manufacturing and career opportunities we 22 offer, this crisis will, indeed, deepen. 23 24 We found manufacturing, as a career choice, ranked fifth out of seven 25 industries in a recent report issued by the Manufacturing Institute and Deloitte 26 & Touche. And to make matters worse, our industry came in dead last with 27 Millennials. 28

1	So parents, teachers and school counselors do not encourage our youth to
2	enter a career in manufacturing. We, on the Workforce subcommittee, want to
3	tackle this public perception problem head-on.
4	
5	We're committed to improve the perception of manufacturing. And to create a
6	positive awareness of the benefits and rewards available to the next generation
7	of American workers. Manufacturing is the foundation of our nation's
8	prosperity.
9	
10	And so, with that in mind, we are pleased and proud to be able to present, to
11	the full Manufacturing Council, our Workforce Development Perception
12	Campaign recommendation letter.
13	
14	Some of the key points - without a doubt, we find that Manufacturing Day is
15	quickly becoming a positive force in select regions of our country. Thus, our
16	first recommendation is to build on this working model.
17	
18	I don't plan to read the letter in detail, but I am going to emphasize specific
19	recommendations that, hopefully, will add to the overview. Recommendation
20	Number 1, building on the successful Manufacturing Day public-private
21	partnership.
22	
23	We recommend launching a much-needed national pro-manufacturing
24	advertising campaign. Many of us on the council were pleased with the
25	progress of Manufacturing Day.
26	
27	And we are all active participants in the program, in some way. We see how
28	the public-private partnership between industry stakeholders like the
29	Fabricators & Manufacturers Association, the National Association of

1	Manufacturers, the Manufacturing Institute and MEP - Manufacturing
2	Extension Partnership -Program, can work effectively together.
3	
4	Our recommendation is to address this pervasive public misperceptions about
5	manufacturing by aiming a national pro-manufacturing advertising campaign
6	aimed at the middle and high school students, their parents and educators.
7	
8	We recommend using Manufacturing Day as the campaign's message
9	centerpiece. Specifically, we're asking the Secretary of the Department of
10	Commerce to engage in the organizations, such as the Manufacturing Institute.
11	
12	This private partner - and if it happens to be the Manufacturing Institute -
13	would act as the campaign's fiscal agent, creative project lead and, also, to
14	guide the work of a national advertising firm.
15	
16	Additionally, we're asking the Secretary to direct the Commerce Department
17	to provide adequate resources for this joint campaign between MEP and the
18	Manufacturing Institute.
19	
20	We're recommending key existing and creative partnerships be leveraged for
21	distribution of multimedia to target the middle and high school students, their
22	parents and educators.
23	
24	Ideally, the direction should be given, by late summer or early fall, for a
25	campaign launch. Attached to our letter, you'll find an appendix. It's a
26	proposed framework for the national pro-manufacturing advertising campaign.
27	
28	Please understand, this framework is a general overview. Our council does not
29	purport to be an advertising specialist. And, thus, we want to leave the
30	specifics to the experts.

1	
2	We believe private funding from major U.S. manufacturers is critical and we,
3	actually, acknowledge this requirement for the public-private partnership to
4	advance.
5	
6	The amount of funding necessary will depend upon the final scope and the
7	objectives of the campaign. But, as in the case of Manufacturing Day, we
8	really believe there will be a strong sponsor base provided by U.S.
9	manufacturers.
10	
11	Recommendation Number 2, expand Manufacturing Day and it's nationwide
12	collective of events and of activities. We asked the Secretary to put the full
13	force of the Commerce Department's weight and power behind Manufacturing
14	Day by asking other government agencies to participate.
15	
16	As we indicate, Manufacturing Day is a successful platform to build upon. It
17	provides middle and high school students an opportunity to visit
18	manufacturing facilities and to learn how advanced technologies are being
19	used.
20	
21	It provides those same children with face-to-face experiences with our current
22	Workforce. Manufacturing Day is the premier vehicle to bridge the gap in
23	communication and collaboration between manufacturers, academia, students
24	and parents.
25	
26	Specifically, we are recommending engagement of the White House, the
27	Department of Education and the Department of Labor. They need to get
28	actively involved.
29	

1 We ask other government agencies with manufacturing facilities, laboratories 2 and research centers to join in and stimulate their manufacturing contacts to 3 do likewise. 4 5 Agencies such as the Department of Defense, Energy, and NASA could 6 allocate optimal staffing and resources to the program. They could help 7 support a bold, successful execution of Manufacturing Day. 8 9 The Secretary currently encourages all of us manufacturers to be part of 10 Manufacturing Day events at our facilities. But we are specifically 11 recommending the Secretary promote company-neutral initiatives, which 12 could be hosted by manufacturing stakeholders such as IMCPs, industry 13 associations, non-profits and educational institutes that focus on 14 manufacturing skills training. 15 16 In our letter, you'll see, we've provided examples of these. The company-17 neutral approach was done quite successfully during last October's 18 Manufacturing Day, in Detroit. Thanks, in large part, to our council members 19 in the region, we have provided, again, some specific bullet points for your 20 review in the letter. 21 22 Manufacturing Day activities were so prominent that they drew the attention 23 of the federal government and administrators, which led to the participation by 24 the White House, Commerce officials and elected officials. 25 26 Our recommendation would create a proactive position of these agencies and 27 officials, rather than a reactive position. Due to the vision of our council 28 members, the efforts drew more than 4,000 schoolchildren. And Michigan 29 rose to the top state, in 2015, with a total of 106 - 7 - 176 events. 30

So, in summary, the Workforce Development subcommittee, through its 1 2 recommendations, asked the full Manufacturing Council to approve our letter 3 to the Secretary of Commerce. 4 5 We strongly believe that developing and launching a national pro-6 manufacturing advertising campaign and boosting the participation of 7 Manufacturing Day will help reshape public misperceptions about 8 manufacturing. 9 10 It will encourage Americans - youth, parents and educators - to continue - or 11 consider manufacturing careers as a practical and exciting way to achieve the 12 American dream. 13 14 It could accelerate the revitalization of our nation's manufacturing talent 15 pipeline. And, ultimately, reduce or eliminate the skills gap, which is expected 16 to result in 2 million manufacturing jobs going unfilled over the next decade. 17 18 We did receive feedback from a number of council members. And I would 19 like to thank those council members, and all of the council, for reviewing our 20 original draft letter. We received many positive responses from our members. 21 22 There were a few suggestions on the draft letter and I'll address those in just a 23 moment. But, before doing so, let me say that the Workforce Development 24 subcommittee and our outside team members worked diligently to research 25 this topic in order to prevent - present a well-thought-out written letter of 26 recommendation. 27 28 And while Andra and Shirish could not be present, I know I speak for them 29 when I say thank you to the whole team, especially the efforts of (Jason 30 Condit), (Mickey Steele) and the directional assistance of Archana.

1	
2	The draft letter was well-received, with comments such as, "Great job,"
3	"Well-done and thoughtful," "Great job, to the whole team," "Nicely done"
4	and, "Very good. No new comments or edits."
5	
6	As to the feedback, we did receive, two actionable comments and both were
7	addressed. The first was from Jan Allman. Thank you, Jan, for your insights
8	and suggestions.
9	
10	Jan wrote that we should consider leveraging social media and online
11	resources, also, promoting manufacturing career paths and technologies. This,
12	she says, could help enhance the effectiveness of Manufacturing Day by, first,
13	providing a sustained resource and tool for increasing awareness of
14	manufacturing.
15	
16	And, second, provide a more optimized delivery mode for younger workers
17	and Millennials. They are far more comfortable and relate to online
18	information.
19	
20	We acknowledged Jan's concerned that the letter call out, specifically,
21	leveraging social media and online resources. As she suggested, this is an
22	optimized delivery approach to the younger workers and Millennials.
23	
24	Thus, we added a clause, in the first paragraph of our first recommendation,
25	specifically identifying the advertising campaign should utilize not only
26	traditional methods, but also include digital and social media as a delivery
27	mechanism.
28	

The other actionable comment was from Christie Wong Barrett. I want to 1 2 thank Christie for her assistance to the process. The subcommittee sincerely 3 appreciated her comments. 4 5 Christie wrote that, in order to enhance Manufacturing Day impact, due to 6 timing in the fall, it is difficult to organize school-age children on trips to 7 manufacturing sites without planning in the year before. 8 9 Opportunities could be either to advertise future site visits or to encourage 10 planning for Manufacturing Day in the prior year, before summer break. We 11 acknowledged Christie's comments as important scheduling concerns. 12 13 We also wish to enhance Manufacturing Day input. And while the specific 14 approach will, likely, be done by the advertising specialists, we attempted to 15 address this comment by inserting an earlier action date for the campaign. 16 17 Under the recommendation Number 1A, we are asking the Secretary to direct 18 the Commerce Department resources by late summer or early fall of 2016. 19 Finally, I want to acknowledge and thank Angelina Chen, Jan's executive 20 assistant, and Dawn Grove for providing valuable corrections to the draft. I 21 would like to open the floor to questions and/or discussion at this point. 22 23 Susan Smyth: Okay, thank you, Mr. Yeager, for providing, basically, excellent context for 24 the recommendation letter from the Workforce Development subcommittee. 25 And I thanks, again, to the entire team for their diligent efforts.
